## Unofficial Minutes for Milton Township Board of Trustees Regular Board Meeting Milton Township Hall – 32097 Bertrand St., Niles, MI Tuesday April 19th, 2016 6:30 P.M.

The meeting was called to order at 7:00 pm and the pledge was recited.

## **Committee Reports**

Renken reports that the former director of SMCAS has a warrant for his arrest, as he has been charged for the alleged embezzlement of \$98,000. Renken went on to report that the missing funds were found to be missing due to the hard work of the present executive director, Brian Scribner.

Renken was unable to provide much information, due to the ongoing investigation. He did note that the alleged embezzlement occurred prior to the Township contracting with SMCAS.

Benjamin reports the contract between Milton Township and the Edwardsburg Fire Department has been submitted for their review.

Brian Scribner, whom is the executive director of SMCAS, addressed the board on various issues. The issues were as follows:

## **Rental Updates**

A sealed bid was submitted by Herman Arnold for the purchase of the Old Township Hall building. (Building Only) The offer was for \$7,000. Mr. Arnold indicated he is willing to wait until August to see if SMCAS can use the building. No action was taken by the board.
