#### PROPERTY TRANSFER AFFIDAVIT PENALTIES

The State requires that any Property Transfer (new deed) be accompanied with a Property Transfer Affidavit (PTA) submitted within 45 days following the date of sale. If not, there are penalties involved--

For Agricultural and Residential property -- the penalty is \$5.00/day up to a maximum of \$200.00 commencing after the 45 days required to file the PTA.

For Industrial and Commercial property – the penalty is \$20.00/day up to a maximum of \$1000.00 for transfers with a sale price of up to \$100 Million – for transfers with a sale price of over \$100 Million, the penalty is \$20,000.00 after the 45 days have elapsed to file the PTA (no per day penalty).

The State Tax Commission also states that the governing body of a local unit may pass a resolution electing to waive the penalty.

WHEREAS, Section 211.27a of the General Property Tax Act requires the buyer, grantee or other transferee of property to file a property transfer affidavit as prescribed by the State Tax Commission, with the appropriate Assessing Officer in the local unit of government in which the property is located; and

WHEREAS, Section 211.27b of the General Property Tax Act imposes penalties for the failure to file a Property Transfer Affidavit after 45 days have elapsed; and

WHEREAS, Section 211.27b of the General Property Tax Act provides that the local governing body may waive, by Resolution, the penalties levied for the failure to file a Property Transfer Affidavit; and

WHEREAS, the Township of Milton hereby waives the penalties for the failure to file a Property Transfer Affidavit within 45 days of transfer.

NOW THEREFORE BE IT HEREBY RESOLVED, that the Township Board of the Township of Milton hereby waive penalties under Section 211.27b of the General Property Tax Act.
